Community Action of Southeast Iowa has programs in Des Moines, Henry, Lee, and Louisa Counties. We have the WIC Program in these counties and in Muscatine and Washington Counties. We are one of 16 Community Action agencies in Iowa.

We are a 501(c)3 non-profit, not a government agency. Federal funding however does support many of our programs.

Eligibility for most programs is based on household income. Depending on each program, some income guidelines can be up to 200% of the federal poverty level.

We have around 120 employees, 7 management staff, and a board of directors. Many agency decisions are made by our board of directors with representatives from southeast lowa. This includes board members in local government, private groups and people who participate in the programs Community Action provides.
