## Day of the Child tips

- Have the booth ready to go by 10 a.m. Saturday, and please stay until 2 pm. Create a fun, attractive booth that identifies who you are. Staff your booth with a person who actively talks with people about your program and services.
- Keep your booth neat, clean, and organized (don't have personal drinks and food on your booth table). All signage must be professionally printed.
- Keep noise level down and music volume LOW, limited to your immediate area. Please be very quiet during the concert.
- No balloons, candy, or pop, as they can be choking hazards. Also, there is no selling of goods or services, or any money exchanges.
- The mall and Community Action are not responsible for lost, stolen, or damaged items.
- All dollies or carts must have rubber wheels. The mall does NOT provide them.
- Do not attach items to mall property; keep a clearance of at least 15 feet from the storefront or kiosk.
- Report any concerns to the Community Action Booth off of Center Court.
- Parents have expressed that they like easy "make and take" items that they can take home to complete. Be sure your logo, name, and contact information are on as many materials as possible.
